ACLC is a nonprofit law firm that engages in strategic litigation and policy work in the areas of mine safety and health, environmental protection, legacy costs of extractive industries on the people, land and economy of the Central Appalachian region, and sustainable energy. ACLC served more than 500 clients in the current year.

Miners' Health and Safety: We provided free legal services to hundreds of black lung victims and widows in federal black lung benefits cases and related litigation. We advocated for strengthened federal regulations reducing exposure to coal and silica dust. We acted as a resource to communities affected by black lung disease as well as to the professional communities that support them by providing information and guidance regarding changes to black lung law, policies and medical research. ACLC also represented miners that were discriminated against for making safety complaints.

4b (Code:) (Expenses \$ 345,700 including grants of \$ 0) (Revenue \$ 0)

Environmental Justice: ACLC continued to provide free legal services to families and communities whose land and environment is directly impacted by coal mining and other destructive environmental practices in our region. ACLC continued to represent one community in its efforts to address failures in its public water system and advocate on behalf of that community and others in the region dealing with similar problems in state and national forums. ACLC also provided analysis and testimony to Congress about the 2022 flooding and the impact of climate change and mountaintop removal mining on extreme weather events.

Policy and Advocacy: ACLC seeks to promote a just transition in Central Appalachia as the coal economy declines, investments are made in new economic and energy futures, and as the region recovers from the July 2022 flood disaster. In 2023, we engaged in educational activities, community group capacity building, policy analysis, and advocacy in pursuit of this goal. We engaged particularly with policy issues concerning black lung benefits, coal mine reclamation, utility affordability, and disaster recovery.

Form 990, Part VI, Section B, Line 11b - The 990 is emailed to all Board Members for review and comment prior to filing with the Internal Revenue Service.

Form 990, Part VI, Section B, Line 12c - Compliance with policy, such as conflict of interest, is dependent on the individual attorney and board members. Professional conflicts are discussed. All are aware that divided loyalties are expressly prohibited.

Form 990, Part VI, Section B, Line 15 - Executive compensation is considered by the Board of Directors at Organization's fall meeting. The Director and Assistant Director compile a budget, which includes compensation levels for each individual employee for the next year. Board approval of the budget is required. At this time, executive compensation is not compared to other non-profit organizations and operations. Management is not aware of any other private or non-profit public interest law offices similar to Organization in Kentucky. When the Organization was founded, attorney salaries were roughly equivalent to what a somewhat comparable Kentucky organization, Appalachian Research and Defense Fund, paid its attorneys.
